Strengthening Faith-Based Organization (FBO) Capacity to Deliver



[INTRODUCTION]



Socio-economic factors also negatively impact an individuals' economic activity, including a lack of education, poverty, cultural and religious discrimination, overpopulation, unemployment, and corruption. Individuals and families across our country are struggling to make ends meet. Last year, about 40% of American families reported hardship in trying to meet at least one of their essential needs, such as paying for food, health care, housing, or utilities. The struggle is real for individuals living in historically underserved communities facing considerable challenges achieving successful life experiences. The impact of poverty and related conditions is known to have dire consequences on academic

achievement, employment, nutrition and health outcomes, stable housing, exposure to crime and other environmental factors, all of which undermine one's quality of life.

Decades of research demonstrate the cyclical nature of poverty, where these lifelong barriers result in negative impacts passing on from one generation to the next. There are clear gaps in access to the opportunities necessary to survive for millions of Americans – let alone thrive – representing a massive pool of untapped potential and talent. Access and choice has a significant impact on the livability, sustainability, and prosperity of communities that make up our boroughs, parishes, towns, counties, and cities.

For the better part of the last fifty years, a major function of the nation's federal, state, and local governments – alongside numerous privately-funded entities – has been to assist individuals in overcoming these barriers. However, as the data reveals, existing government services and practices have not successfully moved the needle to produce meaningful and measurable outcomes.

Taking a closer look at many of the traditional interventions put in place years ago – most have not changed much over time. The existing approaches continue to rely heavily on service

agencies and community organizations that use program-centric models to establish eligibility and provide direct service delivery. These approaches fall short in impacting the needed behavioral change and scale to meet well-being and financial goals. They offer solutions that focus on individual gain and do little to narrow the persistent health and economic disparities by race, education, and geography that impact underserved and at-risk communities.

Historically, FBOs have been particularly prominent in providing food, clothing, and shelter to people in need. The importance of faith-based organizations in our communities must become a significant component of plans from now on. They have the energy, advocacy, experience, and commitment required to build and strengthen families and communities' cohesion. Faith-based organizations are viable organizations doing important work and are well-positioned to do even more.

The "Community1st" approach empowers FBOs to collectively work together across their local communities to identify and address the barriers and threats related to community resilience and sustainability.

[COMMUNITY 1st PROGRAM OVERVIEW]

FBOs represent the third largest component of the nonprofit sector in the U.S., after health and education. These organizations are too important to ignore, especially considering the sheer number of FBOs coupled with the reality that FBOs are among the most vital institutions in disadvantaged communities.
